
## **Description**

The AV113-12 is a current controlled, variable attenuator from Skyworks series of HIP3<sup>™</sup> components. It is designed to meet the wide dynamic range required in IMT-2000 applications. A monolithic quadrature hybrid is teamed with a silicon PIN diode pair in a plastic surface mount package, reducing size and assuring consistency from part to part. AV113-12LF is packaged in a lead (Pb)-free, fully RoHS-compliant SOIC-8 package and is electrically identical to AV113-12.






## **Attenuation vs. Control Current**



Input Return Loss vs. Current Control



Attenuation vs. Frequency




**Output Return Loss vs. Current Control**


