




CAS-2000 Comprehensive Application System Compact High Density Remote Test Unit



Key Features

 - Onboard FLASH Hard Disk memory (optional) and network backup (no floppy or tape drives) for increased system reliability
 - Scalable serving as an administration shelf for up to 8 additional T3AS shelves in any combination: supports up to 48 DS3s, 1120 DS1s or 448 DS1 test from multiple DCSs/TAUs
 - Operates under a variety of OSSs and supports a wide range of DCS and test access devices



JDSU's CAS-2000 provides a solution to help providers meet these challenges.

JDSU has extended the capabilities of its T3AS Test and Performance Monitoring System to bring service providers a compact, low cost, high density entry level solution for managing digital services through the next generation of edge elements. CAS-2000 allows for a compact yet high density entry level DS1 test configuration at the lowest possible price while still enabling full expansion into any DS3/1/0 application. This combined with the capacity of expansion shelves, the CAS-2000 offers the best of both worlds – minimal upfront investment for an entry level configuration while enabling the user to expand without having to reinvest in additional common equipment. The low cost and high density also makes it the ideal solution for the emerging edge based DS1 remote test market as well providing remote test coverage at multi-service provisioning platforms ("MSPP") and small DCS/ADMs for test access. CAS-2000 is the Comprehensive Application System meeting today's service provider challenges.

CAS-2000 Performance Your Monitoring System is a comprehensive platform for remotely testing and monitoring existing and nextgeneration networks. It has been designed to support a multitude of applications at both digital crossconnect (DCS) and non-DCS locations. The CAS-2000 can act as a stand-alone system or as the administration shelf, providing the central processing and communications interfaces to the test access element and test operations system for up to eight other shelves.

Depending on the application, you can multiple employ shelves and subsystems in a variety of configurations. When used with T1 administration links deployed between the base T3AS and the remote shelves, the cost of one centralized administration shelf can be amortized over multiple shelves. T1 administration links can, however, be difficult to implement and expensive to maintain.

The CAS-2000 alleviates this issue. Its much smaller size and lower cost make it economically feasible to deploy as a stand-alone or with stand-alone shelves, eliminating the need to implement complicated and costly T1 administration links for remote testing and monitoring. Therefore, you can use these available T1 circuits to support customer services for added revenue.



The CAS-2000 compact size, high density and low cost makes it cost effective to deploy as a stand-alone shelf for remote test access.

DS3 Test Access Capabilities

The CAS-2000 supports DS1 testing from a 3/1 Wideband DCS. The system supports two single Facilities Access Digroup (FAD) or Dual FAD interfaces providing full support for monitor and split access for up to two DS3s per stand–alone configuration. Additional access capability can be provided using additional subassemblies.

DS 1 Testing Capabilities

Optimal DS1 testing capability is provided in a compact solution. The CAS-2000 supports up to 16 single FAD or 14 Dual FAD DS1 tests. The HiCAT module provides single or dual FAD testing of up to eight (8) signals. The DS1 Access/Test (AT) module provides two (2) single or dual DS1 tests per module. Up to two modules may be added to provide continuous non-intrusive performance monitoring. Additional test capability can be provided using additional subassemblies.

IP connectivity

The CAS-2000 provides IP connectivity while preserving X.25 communications, which allows service providers to migrate easily to a central office WAN configuration that meets their budget and schedule.

Remote software downloads


With the CAS-2000 remote software download functionality, technicians no longer need to visit local sites to upgrade each system. This capability greatly reduces field support costs and allows rapid deployment of T3AS features and enhancements.

Scalability

Once installed the CAS-2000 based DS1 entry level solution can be fully expanded to support up to 8 additional T3AS shelves in any combination for DS3/1/0 DCS/TAU based testing or DS3/1 in-line test. The CAS-2000 has a common OSS and EMS interface for up to 8 additional T3AS shelves in any combination.

Reduced space requirement

The CAS-2000 is a compact 2U high shelf. The shelf is self-contained including a power supply, processor and utility module and 3 slots for adding test and interface modules.



The CAS-2000 is cost-effective to deploy with stand-alone shelves (shown in figure 1), eliminating the need to implement complicated and costly T1 administration links.
