# DPDT SWITCH FOR 2.4 GHz AND 6 GHz DUAL-BAND WIRELESS LAN

#### DESCRIPTION

The  $\mu$ PG2162T5N is a GaAs MMIC DPDT (<u>D</u>ouble <u>Pole</u> <u>D</u>ouble <u>T</u>hrow) switch which was developed for 2.4 GHz and 6 GHz dual-band wireless LAN. This device can operate frequency from 2.4 GHz band and 6 GHz band, having the low insertion loss and high isolation.

This device is housed in a 6-pin plastic TSON (<u>Thin Small Out-line Non-leaded</u>) package. And this package is able to high-density surface mounting.








## MOUNTING PAD AND SOLDER MASK LAYOUT DIMENSIONS

SOLDER PAD


