




- The Blue source color devices are made with InGaN Light Emitting Diode.





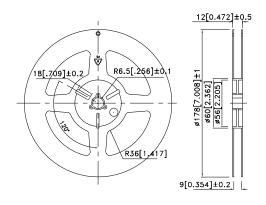


